

You may all be well aware by now that Gwynedd were visited by Estyn in March 2008 to inspect the quality of youth support services in the county. **Estyn's aim is:** *'to raise standards and quality of education and training in Wales through inspection and advice, in support of the vision and strategic direction set out by the Welsh Assembly Government.'*

The whole process was lead by the Gwynedd Children and Young People's Partnership and a number of Third Sector organisations were involved in the preparation work as well being invited to the interviews that followed.

## GWYNEDD'S CHILDREN AND YOUNG PEOPLE'S PLAN 'OUR PLAN, YOUR PLAN'



The first draft version of the Children and Young People's Plan - '**Our Plan, Your Plan**' was presented to the Strategic Partnership and the Lead Planning and Development Group during a joint meeting in May. The purpose of the document is to highlight the priorities and intentions of the Children and Young people's Strategic Partnership for the next three years in order to promote the wellbeing of Gwynedd's children and young people. Partners present were given an

opportunity to discuss the content. A number of comments were raised which resulted in having to change some of the details included before releasing the document for public consultation. The amended version has now been published and it is hoped that relevant parties will have access to either a hard copy or an electronic one. A simpler version will also be available for children and young people (or anyone else who might appreciate a simpler version in that respect).
